- You attended a California Community College (CCC) for at least one term and earned a GPA of 2.4 or higher, and
- You are transferring from a CCC to a qualifying CA bachelor's awarding institution
- You will be younger than 28 years of age on December 31st of the year of your first award

Please read the following carefully, then submit this completed form and all requested documents to Office of Financial Aid as soon as possible. Failure to complete the verification process in a timely manner may result in the loss of your Cal Grant.
